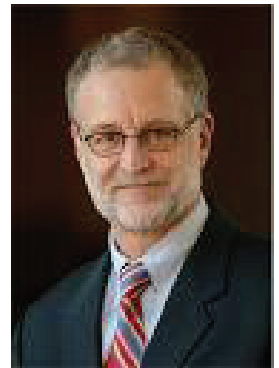
It is estimated that more than two million arrests in the United

States each year involve people with Serious Mental Illnesses (SMI). As a result, untrained and unprepared stakeholders in the criminal justice system have been forced to navigate an increasingly scarce system of care for people with mental illnesses. Jails have become places where a disproportionate number of people with SMI spend significant amounts of time; their ties to the community severed, their treatment needs unmet, and their illnesses made worse. Judge Leifman will discuss the legal history that led to this mental health crisis and the essential elements necessary to create an effective system of care that ultimately will transform the mental health and criminal justice systems and make jail the last option for people with serious mental illnesses, not the first.

For more than 30 years, Dr. Mark Willenbring has focused his work on new treatments for patients with chronic complex addiction problems and implementing evidence based practices in clinical settings. He is the founder and current CEO of Alltyr, an innovative clinic in Minnesota using a new model to treat substance abuse.

Dr. Willenbring is the former Director of the Division of Treatment and Recovery Research of the National Institute on Alcohol Abuse and Alcoholism at the National Institutes of Health and was featured in the HBO Addiction Special.

Unraveling the Mysteries
of Criminal Responsibility

Judge Morris Hoffman will discuss some recent behavioral and neuroscience literature that is starting to shed some light both on what it means for a criminal defendant to act with one of the four mental states recognized by the Model Penal Code (purposeful, knowing, reckless and negligent) and on what it means when jurors or other third-parties reach conclusions about a defendant's mental state, and the implications this research may have on the criminal justice system in general and particularly in the areas of addiction and intoxication.

Paraphilic Disorders in the DSM-5
and the ICD-11 &
The Role of Androgen Reduction
Therapy for the Treatment of
Individuals Who Have Committed
Sexual Offenses

Dr. Richard Krueger is a psychiatrist and Medical Director of the Sexual Behavior Clinic at New York State Psychiatric Institute whose research interests and publications have focused on the psychopharmacological treatment of compulsive and aggressive-sexual behavior. Dr. Krueger will discuss the controversies regarding paraphilic diagnoses, including hypersexual disorder and compulsive sexual behavior disorder. Additionally, he will discuss androgen reduction therapy, including the biological and clinical basis, the current state of use of such therapy, ethical considerations involved in administering such therapy.

Dr. Krueger was on the Paraphilias Subworkgroup of the DSM5 Sexual Disorder Workgroup and currently serves on the Sexual Health Advisory Group for ICD-11 of the World Health Organization.
