Ryan Sanft, LCSW, CDVI

Mr. Sanft is CEO and Founder of Impression Healthcare Services, Inc. a community based forensic mental health facility. For over 6 years Mr. Sanft's organization has been a community partner vendor contracting with local municipalities, including San Bernardino Departments of Mental Health, Children and Family Services, Juvenile Probation and Adult Probation, and the California Board of Registered Nursing.
